The members discussed other issues requiring attention, including communication pieces and the application form. S. Clevely suggested that film grant applicants use a distinct budget summary form similar to the one used by Film Canada.

S. Greutzmacher suggested that the Board implement incremental change only as there remains the need for engagement from the arts community on the current transition to a Peer Assessment Panel model.

The Board discussed the process for evaluating the trial PAP review process. M. Scott suggested that feedback from the Board, the Task Force members, PAP members and support staff will be part of the September regular meeting agenda. The Board agreed to proceed with the fall 2014 round of applications in the same manner as the spring 2014 round.
