The meeting was called to order by the Chair without quorum. M. Scott welcomed Jeff Schelling, Legal Services, Region of Waterloo.

Declarations of Pecuniary Interest under the Conflict of Interest Policy of the Region of Waterloo Arts Fund

None declared; declarations related specifically to the grant applications were made prior to the review of the Stage 1 applications.

Approval of Minutes

a) Open Session - January 16, 2014

M. Scott advised that she wished to add an item to the agenda under Other Business, Correspondence to Stage 1 Unsuccessful Applicants.

Business Arising From the Minutes

- a) By-law Amendment: By-law No. 2
- M. Scott stated that By-law No. 2 was approved by a majority of the Board via an electronic/email vote.
- * M. de Groot and A. Thomas joined the meeting at 3:12 p.m.
- M. Scott summarized the impact of the amendments, specifically the parameters for board size, and the participation of members with direct and indirect conflicts with applications. J. Schelling provided additional clarification about quorum, citing the desire to have no less than 3 members involved in decision-making.

The Board discussed the impact of quorum on transacting business, especially the review of stage 1 applications. The members present agreed that if quorum is lost during an application review, the motion will be emailed to all eligible members for approval.

- M. Scott reiterated that the amending by-law will be the mechanism to move forward with changes related to the application review process.
- J. Schelling advised that new legislation is pending which will require the board to review its by-law; potentially this would be next year and would likely involve a full by-law review.
- b) Task Force Update
- M. Scott stated that the group has met several times to develop the implementation of an accelerated trial review process for spring 2014, using a Peer Assessment Panel (PAP). She noted that this year is a pilot and it's expected that refinements will be made to the review process. Appropriate documents are being prepared for the PAP including Terms of Reference, a Contact Information form and specific Conflict of Interest policy. Only the Task Force will know the identities of the PAP in advance of the evaluation. They will be identified publicly only after the board has made its final granting decisions and a media advisory has been released.

a) Final Reports Review Committee Update

M. Scott advised that the Committee has a meeting date planned for late-April. She stated that the Committee will report back to the Board with an update. She reminded the members that beginning with fall 2013 granted projects, the second installment of

the grant won't be paid until after the Committee has reviewed and approved the submitted Final Report forms.

b) Technical Review of Spring 2014 Stage 1 Applications

M. Scott referred to the technical criteria checklist provided to each board member. She also advised that four (4) applications were received after the submission deadline and have not been distributed to Directors, per the Board's policy. Josh Wise, Cory Crossman, Curt Crossman and Craig Stewart submitted late applications and have been contacted by support staff; each late applicant was encouraged to re-apply to a future round.

Other Business

- a) Correspondence to Stage 1 Unsuccessful Applicants
- M. Scott summarized a proposal to provide supplemental information to unsuccessful Stage 1 applicants in the standardized notification letters. The Board discussed the merits of the proposal. There was agreement that this information was a useful, constructive tool for both Board in their review of applications and for applicants in their understanding of the grant criteria.
- b) Leading Women Building Communities Award
- M. Scott extended congratulations to Isabel Cisterna in being recognized locally for her contributions to the community. A letter of support was forwarded by the Arts Fund and a copy was included in the General Correspondence file.
- c) Website Design Honourarium

A. Thomas recommended that the Board send a 'thank you' letter to Graham Scott for his work on the design of the new website and she suggested that it might be appropriate to give him a token honourarium given the amount of hours and effort he put into the website design development.
