New Business

a) Review / Approval of Financial Statements, dated December 31, 2014

Julie Bradey, Financial Analyst (Tax Policy), provided an overview of the financial statements. Copies of the draft document were distributed to members present and she advised that once approved, copies of the final financial statements will be made available to the board.

She stated that the statements are presented fairly and have received a clean audit opinion by Deloitte LLP. She summarized the statement of revenue and expenses, as well as the accumulated surplus. She highlighted Note 4 related to grants approved, paid and returned. She noted that the audit fees are paid by the Region of Waterloo as a cost-savings measure.

J. Bradey advised that given the recent return of a grant from M. Hurwitz (F13-25), a note will be added to the draft statements and that the money will be part of the 2015 funds available.

In response to a board question regarding the increase in the 2014 Meeting and Travel expenses line, J. Bradey advised that this was a result of additional meetings held in 2014 and was attributed to catering and parking expenses. It was noted that during 2014, the pilot Peer Assessment Panel (PAP) was in place and this resulted in additional meetings being held for the PAP review of stage 2 applications.
