Welcome

M. Scott welcomed the Directors and the Artist-at-Large Advisors. Each Artist-at-Large Advisor provided brief self-introductions.

Business Arising From the Minutes

a) Initiatives and Best Practices for 2015 Update

M. Scott provided an update on the initiatives including a summary of the Artist-at-Large Advisors pilot and highlighted the benefits of the participation by artists within the community. She stated that while the Task Force hasn't yet met, she will remain neutral and won't vote on motions related to applications. She stated that the Open House held in February was well attended in spite of the weather and that she was pleased with the Board participation. She provided details about the Coaching pilot which was launched in February and the participation of former board and/or Peer Assessment Panel members. She advised that the website will be reviewed and revisions made to improve communication with applicants, grant recipients and members of the general public.

Correspondence

a) Paul McGough, Acquaintance (S13-52) Re: Request for Project Extension

The Board discussed the request and directed staff to send written notification of the Board's decision to deny the extension and request that the grant be repaid. The correspondence should also encourage Mr. McGough to submit a new application for his project when circumstances permit.
