Business Arising From the Minutes

- a) Grant Agreement Revisions
- M. Scott summarized the revisions made after the board's review and discussion at the April meeting. Liam Legate, Solicitor, Legal Services, referred to the additional text related to compliance of all laws; this will become clause 18 in the Agreement.
- S. Natolochny noted which text in clause 3 will be deleted and advised that two (2) additional versions will be created for non-profits/unincorporated and incorporated organizations to accommodate the unique signing blocks.

In response to a board question about the protocol for non-compliance with any of the Agreement clauses/conditions, the board discussed the options and precedents. They agreed that any such situation would be reviewed on a case-by-case basis and resolved per approved policy or based on a review of the circumstances; any actions would require approval by the board.

- b) 15 / 150 Update
- M. Scott thanked the board for taking on this special one-time initiative and noted that all information about the 15 / 150 grant is now available on the website. There hasn't been any media or applicant inquiries to date.

She stated that the 15 / 150 Task Force members met and established the foundation for celebrating the 15th anniversary of the Arts Fund. The suggestion was made at that meeting to establish a Facebook page to promote the 15 / 150 grant and/or for more permanent use but the members were made aware that the maintenance of a Facebook

page would require a volunteer since support staff don't have the capacity to be involved in maintaining the page.

The board discussed the merits of the proposed Facebook page. It was agreed that social media plays an important role in community engagement but members expressed concerns with monitoring the page and control over posts left by others. Suggestions were made to set-up the page strictly as a broadcast tool or just to promote the 15 /150 grant. There was discussion about the technical elements of social media communication. The board agreed that Facebook has the potential for community building and positivity. M. Scott suggested that board members with their own Facebook pages could post a link to the Arts Fund home page to promote the Arts Fund in general.

- B. A. Keller provided an update about the proposed 15 / 150 event to celebrate the 15th anniversary of the Arts Fund, including the logistics of hosting a volunteer reception. She's made some initial inquiries for a venue with a tentative date in early-May 2017. M. Scott suggested that a budget be set and that the board discuss the proposal for the event in more detail at the September meeting. The board had some discussion about the invitation list and it was agreed to limit this due to budget considerations.
- c) Website Content Management System (CMS)
- S. Natolochny gave an overview of her inquiry with REM Web Solutions, noting the benefits of contracting with the local company and the concerns with the status quo. The estimate provided for a one-time website re-design and uploading fee is approximately \$5000, as well as the monthly web-hosting and 24/7 technical support fee; a discount has been given due to the non-profit status of the Arts Fund.

The board commented on the reasonable fees and the available add-on options as the website needs evolve (i.e. online applications). There was general agreement to investigate the proposal further. M. Scott advised that there is an opportunity for a REM demonstration for any interested board members and staff. The issue would then come back to the September meeting for further discussion and a decision. Staff will send out a poll to determine best date and time for the demonstration.
