Acknowledgement of Traditional Lands

B. A. Keller acknowledged that the board is meeting on the traditional territory of the Neutral, Anishnawbe and Haudenosaunee people.

B. A. Keller introduced Peter Shannon as an Artist-at-Large volunteer for the Spring 2017 session with an expertise in film. She also welcomed Michele Hopkins to the board and noted that Rob Waldeck will be attending the next meeting.

Business Arising From the Minutes

- a) 15/150 Reception Update
- B. A. Keller gave an update on the plans for the May 11th reception. She distributed a draft agenda for the event and a sample brochure that she's designed to be printed and handed out at the reception. She's working with designer, Timm Vera and she distributed a draft brochure that he's designed. She identified the items required for the event, such as a screen, projector and laptop.

A. Dobkowski provided an update about the event expenses stating that it's not possible to cover the event costs with \$1500, given the catering expenses. She suggested that the board consider increasing the limit for the event expenditures to \$2500.

The board discussed the potential costs and purpose of the full-colour brochure, as designed by T. Vera.

- b) Website Redesign Update
- M. Scott provided an update on the re-design process. REM is in the building stage with all content in hand. She anticipates that an update, with a first version, will be coming from REM next week. The site will be shared with the board prior to going live.
- B. A. Keller raised the issue of training for board for volunteers; she, M. Scott and P. Mulloy are interested in attending the training as are support staff. B. A. Keller noted that a lead will be required. M. Scott will coordinate the training details.

a) Robert Motum F15-08 Re: Allocation of Grant Surplus

B. A. Keller provided an overview of the request, noting that R. Motum has requested that the surplus from the first grant installment be shared among the involved artists and that the second grant installment (\$485) not be paid out to him, per his request, and given the preliminary total project surplus. Staff will send out the notification to Mr. Motum.

- b) Nota Bene Baroque Players F16-57 Re: Request to Revise Project
- B. A. Keller provided a summary of the request to revise the venue and audience changes, as outlined in the submitted proposal.
- * R. Nixon joined the meeting at 1:46 p.m.

The board discussed their concerns that no rationale for the change is noted in the request, nor is a list of potential performance venues. The board also discussed the rationale options that they would be prepared to accept. The board directed B. A. Keller to follow-up with M. Pare to seek more information and make a decision based on his reply.

New Business

- a) Communications Update
- B. A. Keller read an endorsement from Dr. Bryan Smale, University of Waterloo Canadian Index of Wellbeing. She stated that an endorsement has also been requested from Kathryn Townsend, Director of Research, Policy and Evaluation, Ontario Arts Council these testimonials will be added to the website page and will be highlighted during the volunteer reception, along with other testimonials.

She summarized her recent meeting with Bryan Stortz, Director, Corporate Communications at the Region, including his suggestions for continued use of testimonials, stories about grant recipients, and the development of a "best minds group".

- P. Mulloy provided an overview of the proposal for Social Media Guidelines, as distributed to the members in advance of the meeting. The board discussed the merits of the proposed guidelines. She added that it doesn't make sense to set up social media sites since currently there are no board resources to maintain any sites.
- B. A. Keller reminded the board that the Social Media Guidelines don't oblige any board member to update Arts Fund news on their personal social media sites but she encouraged those willing and comfortable to share the Arts Fund message. She noted that the board will review this issue in a year. Staff will update the board's policy and procedures binder accordingly.

- M. Scott provided an update on the Request for Proposal for the 15/150 Grant projects videos. She noted that seven (7) proposals were received and reviewed by herself, B.A. Keller and Scott Clevely, a former board member with experience in the film industry.

The proposal offered by MetaMedia Productions is being recommended for board approval. Legal Services has drafted an Agreement for the project. She added that 50% of the videos project cost will be paid once the first three (3) videos are completed and the balance will be paid when the other three videos are completed.
