a) Review of Draft Recruitment Advertisement

B.A. Keller reviewed the draft advertisement to recruit Arts Fund Board members, asking for input on where the ad could be placed in addition to the regular local papers, especially the smaller community papers that serve the townships. It was noted that a published ad for Board members is a way to ensure transparency and openness in the recruitment process. Suggestions included using Public Service Announcements with local media, university publications, Spacefinder Waterloo Region, and previous grant applicants to recruit for new members. There are job description and recruitment documents that can be shared with candidates. Often the Board is looking for a member with a specific area of expertise and one-on-one conversations can be the best way to share information with potential new Board members. It was decided that no ad will be placed at this time, but B.A. Keller will continue to work with staff to best choose how to advertise for new Board members. As well, current members should use their own social networks to spread the message.
