# **Business Arising From the Minutes**

a) Website SSL Certificate

Ian Ring explained that an SSL Certificate encrypts all requests & responses from the web server, works to prevent snooping and is required for any e-commerce transactions on a website. While it is not required, it would put the Arts Fund website higher in the ranking for any Google searches. He noted the Board could either choose to have no SSL Certificate for the Arts Fund website, or to pay \$100 annually for one being offered by REM Web Solutions, which is their cost to obtain a certificate for the Arts Fund site.

d) Lenore Brooks, Kitchener-Waterloo Little Theatre (KWLT) re: Reinstating KWLT as an Applicant in Good Standing

B.A. Keller gave some background regarding applicants disqualified from receiving future grants, and some history on Kitchener-Waterloo Little Theatre (KWLT).

The Board expressed concern regarding accountability by the organization and wanted to be careful about setting a precedent. The policy regarding disqualifying an applicant says that grant recipients who don't comply with all conditions of the Grant Agreement will be disqualified from receiving future grants, and an important condition of a grant is to submit a Final Report. Once a disqualified applicant complies, they are then allowed to apply for future grants.

B.A. Keller noted that, according to their records, the current Board of KWLT have no knowledge on what specifically the grant money was spent. With current electronic options record keeping is much improved, and Canada Revenue Agency only requires record keeping for 7 years, so for the Board to expect more than that would be unreasonable. It was also noted that, 14 years later, the organization has rebuilt itself with all new people in place, as well as a new Board.
