1. Social Media Coordinator Update

Bill Chesney, President, provided an update regarding the Arts Fund contract with Martin de Groot, who was hired as Social Media Coordinator to establish the Arts Fund Facebook page and social media presence. The contract provided for a mid-term check-in and B. Chesney recommends the contract be terminated at this time, as is allowable in the agreement.

New Business

1. COVID-19 Response and the Region of Waterloo Arts Fund

B. Chesney reviewed the decision process taken by the Arts Fund at the beginning of the COVID-19 pandemic. The motion was circulated on April 10, 2020 and voted on via e-mail by the Board of the Region of Waterloo Arts Fund.

Given the extraordinary circumstances faced by Region of Waterloo Arts Fund grantees, and all artists across the Region, due to COVID-19 and the public health measures in place, be it resolved that the Region of Waterloo Arts Fund take the following actions:

- 1. That all Spring 2020 applicants be invited to submit a Round 2 application and be directed to submit their completed application by email only;
- 2. That a question be added to the Round 2 application that specifically addresses how the project will address current or possible future public health restrictions that might impact the grantees' capacity to complete their project (e.g. prohibition of public gatherings, social distancing measures, etc.);
- 3. Given the above, that Round 2 applications be allowed to propose projects that may differ substantially from the request made in Round 1;
- 4. That 100% of the Spring 2020 funding granted be provided to the grantee immediately (instead of withholding 10% pending receipt of a final report);
- 5. That all successful Spring 2020 grantees be given until August 1, 2021 to complete their projects; and
- 6. That successful Spring 2020 grantees be permitted to also apply for different projects during the upcoming Fall 2020 and Spring 2021 rounds, constituting a temporary lifting of the application guideline that artists may not apply for new projects while a current project is still underway.
